WHY THIS FORM?

MODEL IV

With this form, persons can submit an application for a certificate by operation of law (Article 3 National Ordinance Admission and Deportation).

Who are eligible for a legal statement?

The following persons are admitted by operation of law in Sint Maarten (Article 3 LTU):

- a. persons sent by the government (read: "foreign nationals" appointed in national or island service, usually Dutch nationals, not N / A), before the time of their appointment;
- b. persons who have been employed by the Netherlands Antilles or of one of the Island Territories and on that account receive a pension or benefit by way of pension, as well as the widows of such persons not remarried;
- c. professional consuls, professional consular officers and other consular personnel;
- d. military personnel, during the time they are stationed in Sint Maarten;
- e. persons on board of ships or aircraft belonging to the sea or air force of any power, during the time that St. Maarten is visited with the permission of the competent authority;
- f. Dutch nationals of age, not N / A, provided they meet certain conditions (declaration of good conduct, housing and sufficient means of support); these conditions are deemed to have been fulfilled for the Dutch citizen naturalized in the Netherlands Antilles / Sint Maarten;
- g. the spouse and minor children of the persons referred to under a, b, c, and d, not legally separated from each other;
- h. minor children of the persons referred to under f, provided they are Dutch nationals and are under the parental authority or guardianship of that person;
- i. persons, born in the Netherlands Antilles / Sint Maarten, who do not have the Dutch nationality, provided they have reached the age of sixteen and have been admitted continuously since their birth in the Netherlands Antilles / Sint Maarten.

What will happen to your application?

Only if you have submitted your application complete, with all required documents, to the Immigration Service will your application be processed.

According to the law, the Minister of Justice may in principle take 4 months to make the decision. You will be notified in writing when a decision has been taken on your application.

If you change or change your address, you must immediately notify the Immigration Service that issued the permit by means of a model V (Change of address form). Failure to comply with this obligation may affect the period of validity of the permit.
